We believe that the ongoing and growing commitment to environmental protection and the enhanced safety and health at the workplace contribute to strengthening the competitive strength of the company to the benefit of customers, owners and all stakeholders.

As part of this system, Top Management is committed to:

- Preventing pollution, promoting health/safety/hygiene prevention by adopting measures to continuously improve performance of the implemented systems
- minimising emissions by adopting stricter limits than those required by law
- minimising depletion of resources by monitoring and limiting energy consumption
- ensuring compliance with applicable environmental and occupational health/safety/hygiene legislation and regulations, as well as with all other subscribed requirements
- providing means and resources required to implement the Environmental Management System and the Health and Safety Management System, in particular with regard to the programmes aimed at achieving objectives and targets
- raising awareness, empowering and involving on a widespread basis personnel at all organisational levels
 by promoting the development of worker participation and empowerment in relation to environmental
 and health/safety/hygiene issues concerning their products/processes/tasks and compliance with the
 defined procedures
- identifying the most appropriate sources for communicating the main initiatives having an impact on the environment and the health/hygiene/safety of all personnel to stakeholders
- ensuring that environmental and occupational health/safety/hygiene aspects are duly addressed, both in the definition of new activities and in the review of the existing ones
- ensuring continuous improvement of the environmental, health and safety management system

- requests from stakeholders (workers; social partners; customers and suppliers).

These documents shall be reviewed/reissued by the company every time an internal change is made and at least every four years.

The company shall also keep the Risk Assessment Document and the document containing the significant environmental

aspects available to stakeholders.
